Public Notice

(Advertisement No. 7/2026)

In the **Advertisement No. 7/2026** dated 07.04.2026 issued by HPRCA, Hamirpur regarding the post of **Teacher (Commerce)** (Post Code-26020), one of the Minimum Essential Qualifications, for the above post, was mentioned as following:-

- **Bachelor of Education (B.Ed.) as professional qualification from a recognized University/Institution with minimum 50% marks and should have passed Teacher Eligibility Test (TET) conducted by H.P Board of School Education, Dharamshala, District Kangra or any other Agency authorized by the Government.**

Now, the Director of School Education, HP has issued the clarification that the candidates who possess the Bachelor of Education (B.Ed) in any stream (NM/M/Arts) and have qualified Teacher Eligibility Test (TET) in any stream (NM/M/Arts) along with a Master's Degree in Geography from a recognized University, shall be considered eligible for the said post. Further, the same clarification shall apply in respect of all other such candidates, who have done post graduation in any of the concerned humanity subjects but qualified B.Ed/TET in Sciences.


As such, it is hereby notified to all concerned that **the candidates who possess the Bachelor of Education (B.Ed) in any stream (NM/M/Arts) from a recognized University/Institution with minimum 50% marks and have qualified Teacher Eligibility Test (TET) in any stream (NM/M/Arts), conducted by H.P. Board of School Education, Dharamshala, District Kangra or any other Agency authorized by the Government, along with a Master's Degree from a recognized University with minimum of 50% marks in aggregate in the subject concerned, as notified in the advertisement notice shall be eligible.**

Therefore, in order to provide equal opportunity to candidates possessing the requisite essential qualifications, it has been decided by the competent authority to revive Advertisement No. 07/2026 for a further period of 06 days i.e. from 11.05.2026 at 10.00A.M to 16.05.2026 up to 11:59 P.M.

Accordingly, eligible and desirous candidates are advised to apply online well in advance to avoid any last-minute rush.




